

## ZULEIKHA MUSIC LICENSING AGREEMENT

This is an agreement ("Agreement") made on this the \_\_\_ day of \_\_\_\_\_, 2019, between Zuleikha Bethami/Swan Lake Publishing ("SLP") and \_\_\_\_\_ ("Licensee") for performance of the song "\_\_\_\_\_" ("song") recorded and owned by Zuleikha Bethami / Swan Lake Publishing ("Zuleikha").

**1. PERFORMANCE of THE SONG:**

Permission to perform the song is granted exclusively for this purpose and these dates, and does not extend to any other performance of the song.

**2. COMPENSATION:**

a. Licensee shall pay SLP the following for performance of the song  
(i) A payment of Fifty Dollars and No/100s (\$50.00).

(ii) In addition, Licensee shall pay SLP the following for performance of the song included in digital content (online, downloadable, streaming and any other digital form of distribution) and recorded content (DVD, CD, and any other physical form of distribution):

(i) Licensee shall pay SLP five per cent (5%) of royalties Licensee receives for sales of digital and recorded conference content that includes the song.

(ii) Licensee shall send accounting of such royalties to SLP within thirty (30) days after Licensee is paid such royalties. Licensee shall send such accounting with payment to Zuleikha at Swan Lake Publishing's address listed below.

(iii) In the event that Licensee directly sells digital or recorded content that includes the song, Licensee shall pay SLP five per cent (5%) of such proceeds within thirty (30) days of sale, and send payment with accounting to address below.


**3. CREDIT:** Licensee shall give Zuleikha appropriate credit in relation to performance of the song and in printed/recorded material, and where any reference to Licensee's performance of the song is made. Such credit shall be in substantial form: "song" © Zuleikha.

**5. JURISDICTION:** This Agreement shall be construed in accordance with the laws of the State of New Mexico and its validity, construction, interpretation and legal effect shall be governed by the laws of the State of New Mexico. The appropriate jurisdiction for any legal dispute and lawsuits filed under this agreement shall be filed in Santa Fe County, New Mexico.

**6. ENTIRE AGREEMENT:** This Agreement sets forth the entire agreement between the parties with respect to the subject matter hereof. No modification, amendment, waiver, termination or discharge of this Agreement, shall be binding upon either party unless confirmed by a written instrument signed by both parties or their agent.
